OFFICIAL RULES

1. Basic A/V equipment (microphones, a sound system for music, electricity, and lighting) will be available for performers. Please list all technical requests/needs on the application form provided. We will do our best to accommodate all requests, however no requests are guaranteed.
2. Smoke machines are not permitted.
3. All performances should be in good taste and should be appropriate for families and children of all ages. No profanity, nudity or suggestive content is allowed. Acts containing music, lyrics, gestures, costumes or material that the judges consider to be offensive or inappropriate will be disqualified and will be stopped immediately.
4. Each act is limited to 5 minutes of actual performance time or less. Time required for setup/teardown can be discussed with Morrison Ranch and show coordinators prior to the date of the show.
5. Participation is open to performers of all ages, however participants who are under the age of 18 will need to have their application signed by their parent/guardian.
6. Judges will base their evaluations on showmanship, content, creativity and the quality of the act.
7. The panel of judges will include members of the community as well as the Morrison Ranch Board of Directors and staff.
8. The panel of judges will determine first, second and third place awards, to be presented on the night of the live competition.
9. Applicants need to come on time to all talent show events including the live auditions (unless a video audition is submitted), a mandatory dress/tech rehearsal on the day of the event (Saturday 1/27/18), and the live show on Saturday 1/27/18. Participants need to arrive no later than **1:00pm** on the day of the live show. More details will be available following auditions.
10. Morrison Ranch, the Morrison Ranch Community Council, and CCMC are not responsible for any injuries or damages occurring while auditioning or performing as a part of the Morrison Ranch's Got Talent competition.
11. Morrison Ranch has the sole authority to disqualify any contestant or group at any point in the contest for failure to comply with the rules and regulations stated above.

Audition Information

1. Interested participants can audition either in person or with a video submission.
2. In-person auditions will be held at the Farm Bureau Building (325 S. Higley Rd., Suite 110, Gilbert, AZ 85296) at the following times:
 - Tuesday, January 9th; 5-7pm** (please sign-up using the link provided in this email for Tuesday.)
 - Saturday, January 13th; 1-3pm** (please sign-up using the link provided in this email for Saturday.)(Applicants wishing to audition in person only need to attend one of the two available audition times.)
3. Video submissions can be sent in one of the following ways:

4. Your audition piece must be the complete and final version that you will perform. This is primarily to prevent repeat musical numbers and to evaluate the content of the performance and the appropriateness. If it is not possible for the entire group to attend the audition or if it is not possible to audition the exact performance for any reason, please speak to Tasha Fink and alternate arrangements can be made on a case-by-case basis.
5. Only acts that have auditioned and been selected will be eligible to compete in the final show.
